Ms. Herman reported that she was working on month end, quarter end and year end.

Mr. Hanson informed the Board that no numbers had be released on the Highway Bill that was approved last month.

Mr. Hanson stated that the Rural Task Force was meeting tomorrow. The Village of Mesick is requesting access to Federal Funds and Missaukee CRC will be requesting additional dollars for their projects. By granting these requests our overlay on Baxter Bridge Rd. would be delayed one year. That would not cause significant deterioration to the road. Mr. Hanson anticipates \$600,000 in Federal projects this year.

Mr. Cooper discussed the possible refurbishing of truck #47.

Mr. Cooper informed the Board of a R.O.W. dispute in Haring Township on Milne Rd. off 47 Rd. Mr. Ron Gwolza claims it is not an Act 51 road, however, it is on the Act 51 map.

Mr. Cooper updated the Board on a R.O.W. issue with Dr. Lim around Lake Mitchell.
